Under the terms of the strategic alliance, the Company shall provide ScanScout with the following services with respect to specified websites belonging to ScanScout ("**ScanScout Network**"): (a) distribution of the Company's Target-Overlay to ScanScout Network; and (b) distribution and/or sales of ScanScout Network, directly or through third parties media agencies, direct advertisers, etc outside of the United States of America and Canada. Revenue generated by the Company with respect to any campaign generated through Target-Overlay shall be shared between the Company and ScanScout.
